#### **Student Learning Outcomes:**

As a result of instruction, students will be able to:

Standard 1 – Artistic Perception

Listen to and analyze music, describe music and the use of musical elements.

• Standard 2 – Creative Expression

Create, perform, and participate in music. Play various genres, styles, and cultures with expression, tone quality, and articulation by oneself and in ensembles.

#### Course Description:

String Orchestra is designed as both a performing class and a training group. Musicians of all levels are welcome to participate.

Older students may take this course to practice and develop their leadership skills.

Assessment and Grading (BP 5121 / AR 5121): To ensure that every student has an equal opportunity to demonstrate their learning, the course instructors implement aligned grading practices and common assessments with the same frequency.

1. Grading categories, percentage weights, and collected evidence:

### Artistic Perception – 20%

Listen to and analyze music, describe music and the use of musical elements. Students will be expected to observe three performances outside of the MVHS Instrumental Music Program each semester. They must submit a two-paragraph analysis of each performance.

### Creative Expression – 60%

Create, perform, and participate in music. Play various genres, styles, and cultures with expression, tone quality, and articulation, by oneself and in ensembles. Students will be assigned regular practice quizzes and will be asked to perform an excerpt individually or within a small group. Students will be assessed according to the Performance Rubric.

#### Ensemble Skills - 20%

Rehearsal work ethic, sectional preparation, listening, live adjustments, blending, and professionalism are all part of the grading in an ensemble class where individual skills impact group performance. Students will be assessed on their participation based on the guidelines and expectations distributed during the first week of each semester. Students will occasionally self-assess their behavior.

2. Grading scales:

Grading scale: 100 - 90% = A, 89.99 - 80% = B, 79.99 - 70% = C, 69.99% - 60% = D, 59.99% & Below = Incomplete **Note:** Dropping this course mid-season may result in a Withdrawal (W)

- 3. Homework/outside of class practices (AR 6154):
  Instrumental Music Students are expected to practice an appropriate amount of time ea
  - Instrumental Music Students are expected to practice an appropriate amount of time each week in order to achieve proficiency on their instrument individually and as a member of the ensemble.
- 4. Excused absence make up practices (<u>Education Code 48205(b)</u>):

  Students with an excused absence will have the opportunity to make up a missed practice quiz. They must schedule an appointment with me during tutorial or after school to make-up a performance quiz.
- 5. Academic integrity violation practices (MVHS Academic Integrity Policy):

There are no course-specific guidelines for academic integrity violation. Please see the MVHS Academic Integrity Policy: Honesty, trust and integrity are vital components of the education process. #### 6. Late work practices:

Our department believes that all work must be of an excellent quality which means that constant improvement is a necessity. Students are expected to practice until they master their musical part. Late or missing assignments will be marked as 'Incomplete' until requirements have been satisfied.

#### 7. Revision practices:

See number seven above. Specifically, students will have the opportunity to retake practice quizzes before the deadline of: Monday before each concert.

8. Extra credit practices:

Extra credit will not be available for this course.

9. Additional grading practices:

Students will be provided a performance rubric as well as criteria for participation at the beginning of each semester. This will allow the students to participate in self and peer assessment.
